### Waiver and Enrollment Instructions for Domestic Students Only Full-Time, Part-Time and Graduate

The following is information regarding the Enrollment and Waiver procedures for students enrolled at Bowie State University for the 2011-2012 school year. #### **POLICY TERM**

The insurance under Bowie State University's Student Accident and Sickness Coverage becomes effective at 12:01 a.m. on August 30, 2011. An Insured Person's coverage becomes effective on that date or the date the application and full premium is received by the Company or Plan Administrator, whichever is later. The Spring Semester is effective at 12:01 on January 23, 2012 and will terminate at 12:01 a.m. on August 30, 2012.

#### **ELIGIBILITY**

<u>Full-Time Undergraduate Domestic Students:</u> All full-time undergraduate Domestic students are automatically enrolled in the Bowie Basic Insurance Plan and, the premium charge will appear on your tuition bill. If you have existing health coverage under another policy (self, parent, spouse, etc.), you may waive the Bowie Basic Insurance Plan by submitting a waiver and presenting evidence of your own annual health insurance coverage. The waiver form is available on the Program Administrator's website at: <a href="www.ajfusa.com">www.ajfusa.com</a>. The only way to waive the insurance is through the online waiver. If you waive the plan, you will not be charged on your tuition bill. **The deadline for requesting a waiver for the annual insurance premium is October 15, 2011.**

<u>Part-Time and Graduate Domestic Students:</u> Part-time and graduate domestic students are <u>NOT</u> automatically enrolled in the Bowie Basic Insurance Plan. #### **VOLUNTARY OPTIONAL PLAN**

All Full-Time Undergraduate, Part-Time and Graduate Students who are enrolled under the Bowie Basic Accident and Sickness plan may also purchase Part III – Voluntary Optional Student Accident and Sickness Medical Expense Benefits on a Voluntary basis. The semester premium for the Voluntary Optional Plan is \$375.00.
